



**IX PRIZE FOR RESEARCH ON PERFORMING ARTS  
FOR CHILDREN AND YOUNG PEOPLE JUAN CERVERA  
ASSITEJ· ESPAÑA**

ASSITEJ-ESPAÑA, with the aim of stimulating and promoting research work, as well as the generation of knowledge in the field of theatre for children and young people, convenes... **IX Prize for Research on Performing Arts for Children and Youth Juan Cervera**, which will be governed by the following:

**TERMS OF THE CALL 2019**

1. Authors of any nationality may participate in this Competition with works that investigate issues related to the performing arts for children or young people and are written in Spanish.

The subject matter will be completely free, but curricular proposals, adaptations or consolidations will not be accepted. The jury will especially value projects that contemplate the development of a research paradigm with a methodological structure well differentiated in its phases.

The texts must be original, unpublished in any type of medium and not awarded in another competition, requirements whose failure to comply will result in the loss of the prize. Each contestant may present only one work.

2. The material will be emailed to [premios@assitej.net](mailto:premios@assitej.net) as follows:

In the subject of the e-mail will appear written **“IX Premio Juan Cervera de Investigación sobre Artes Escénicas para la Infancia y la Juventud”**

The body of the message will contain only the **Title of the work and the motto** (or pseudonym).



Three files will be attached by email, whose maximum size will not exceed 5 megs:

- A file will include the texts in **PDF format**, will be named with the **Title of the work and motto** (or pseudonym). Only the title of the work and slogan will appear on its cover, unsigned.
  - Its minimum extension must be 70 sheets folio size or Din A4, numbered, with right and left margins of 3 cm and upper and lower 2'5 cm. The text must be typed with double spacing and Arial or Times New Roman font, size 12.
  - The other file should be named **Plica** and include: Title of the work and motto (or pseudonym), full name of the author, address, telephone, e-mail, as well as a brief curriculum of the author.
  - The third file will be the DNI, Passport or Official Identification Document scanned in JPG, JPEG or PDF format.
3. The deadline for receipt is 24 November 2019, at 24.00h. (Spanish mainland time).
  4. A single and indivisible prize of 2,500 euros and a commemorative trophy will be awarded for the best work submitted to the competition in the opinion of the Jury, which may declare it void, but not divide it. No runner-up prize will be awarded. This prize will not be on account of author's rights.
  5. The tax obligations deriving from the prize will be exclusively that of the winner, who will be subject to the legal deductions.
  6. The author will keep all his or her rights over the awarded work. In the case of any publication of the same, the legend "IX Premio Juan Cervera de Investigación sobre Artes Escénicas para la Infancia y la Juventud" must appear on the cover and in a prominent place inside, and the author undertakes to deliver five copies to ASSITEJ - Spain.



7. The members of the Board of Directors of ASSITEJ-Spain or the authors who have obtained it in any of the two previous editions will not be able to present themselves to this prize.
8. The Jury's decision, which will be final, will be made public in the second half of February 2018.
9. The prize-winning work may be published by the Association within its ASSITEJ-Spain Essay Collection and under the usual conditions of publication of this collection. The jury and the board of directors will decide whether or not to publish the winning work.

In the event that the publication of a work is decided, the author undertakes not to authorise any other publication of the text until 6 months after the publication by ASSITEJ España.

10. In the event that, in addition to the prizewinner, the Jury advises the publication of any of the texts in competition, the person acting as secretary of the same may open the corresponding submissions to request the author's authorisation.
11. ASSITEJ-Spain will destroy the files within a period of three months from the date of the Jury's decision.
12. Participation in this competition implies full acceptance of these Rules, the decision of the Jury and, in the case not specified therein, the decision of the Jury. No correspondence will be maintained with the authors.
